Overview of Typical Career Paths

Corporate Law

The study of how shareholders, directors, employees, creditors, and the other stakeholders interact with one another in compliance with regulations. Corporate law affiliations include partnerships, i.e. law firms, trusts, i.e. pension funds, or companies limited by guarantee like most charities.



Business

Legal Studies majors can work for companies in human resource departments and help create workplace regulations and policies that stay within legal guidelines. They are able to assure employees of their legal rights and can help with conflict resolution within the workplace. Anyone pursuing a career in administration would benefit from this degree.

Law Enforcement

Legal Studies also prepares students for a career in Law Enforcement. Law Enforcement positions are available in many governmental agencies. The largest employers are the Department of Homeland Security, Justice and Treasury. Other agencies include the FBI, CIA, IRS, Customs and Border Patrol.
